

**ORDINANCE 2019-03**

**AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE 2001-05  
AMENDING A TOTAL USER CHARGE FEE PER 1,000 GALLONS.**

**WHEREAS**, it is necessary that for the efficient operation of the City of Gassville sewer system that rates for services rendered be checked periodically and;

**WHEREAS**, a review of the City of Gassville sewer system user rates was completed by the Arkansas Rural Water Association and;

**WHEREAS**, the current rates for the City of Gassville sewer system for services rendered was determined to not be sufficient for the overall operation of the system.

**NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE  
CITY OF GASSVILLE, ARKANSAS:**

That Section 7 of Ordinance 2001-05, is amended to read as follows:

SECTION 7: That the following rates that the City Council hereby finds and declares are fair, reasonable, and necessary minimum rates to be charged for sewer services rendered by the City of Gassville sewer system:

Total User Charge- per 1,000 gallons:

Minimum bill per user= OM&R for 1,000 gal. = Debt Service = Depreciation Reserves  
\$6.50= \$5.40 + \$0.76 + \$0.34

Per 1,000 gallons beyond first 1,000= OM&R for 1,000 gal. + Debt Service +  
Depreciation Reserves.

\$6.50= \$5.40 + \$0.76 + \$0.34

ORDINANCE 2019-02

**AN ORDINANCE TO BAN SMOKING AT CITY PARKS AND ALL CITY OWNED BUILDINGS AND GROUNDS WITHIN THE CITY OF GASSVILLE, ARKANSAS, DEFINING SMOKING PRODUCTS, PENALTIES AND ENFORCEMENT FOR VIOLATION, AND FOR OTHER PURPOSES.**

**WHEREAS:** smoking has been proven to be detrimental to one's health and second hand smoke is undesirable and harmful also; and

**WHEREAS:** litter from smoking is unattractive and does not promote an environment of cleanliness in City parks, buildings or properties.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GASSVILLE, ARKANSAS:**

**SECTION 1. LOCATIONS.**

Smoking shall be prohibited in the following locations: (1.) All City owned parks (including) ballfield, playground areas, pavilions, ball courts, restrooms, parking lots or any other area of parks not named. (2.) All City owned buildings and grounds (including) City Hall, Community Center, Fire Department, Police Department, Public Works, Hwy 62 East property and all parking lots and property not named herein that is owned by the City of Gassville, Arkansas.

**SECTION 2. DEFINITIONS.**

The following defined products shall be prohibited from use within the ordinance:

- (1.) Cigarettes: whether bought packaged or made with can or pouch tobacco individually.
- (2.) Cigars: whether bought packaged or made with can or pouch tobacco individually.
- (3.) Pipes: for the purpose of smoking tobacco.
- (4.) E-Cigarettes: all electronic or battery form of (tobacco free) products that are used to inhale or vape.

**SECTION 3. PENALTIES.**

Any person found guilty of violating this ordinance in the District Court of the City of Gassville, Arkansas shall be guilty of a misdemeanor and a fine of not less than \$25.00 twenty-five dollars nor more than \$100.00 one hundred dollars for the offense.
