ORDINANCE NO. 2022-07

AN ORDINANCE AMENDING ORDINANCE NO. 98-08 WITH REFERENCE TO ZONING WITHIN THE CITY OF GASSVILLE, ARKANSAS RELATIVE TO CHANGING AN AREA ZONED RESIDENTIAL (R-3) TO COMMERCIAL (C-2).

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GASSVILLE, ARKANSAS:

THAT A PROPER PETITION WAS FILED BY THE PROPERTY OWNER (ARLYND MALLETT) REQUESTING A CHANGE IN ZONING; THAT SAID PETITION WAS SUBMITTED TO THE GASSVILLE PLANNING AND ZONING COMMISSION OF THE CITY OF GASSVILLE, ARKANSAS; THAT NOTICE OF SAID PETITION AND PUBLIC HEARING WAS PUBLISHED IN A NEWSPAPER (THE BAXTER BULLETIN) HAVING LOCAL CIRCULATION AS REQUIRED BY ORDINANCE NO. 98-08; THAT A PUBLIC HEARING WAS HELD (OCTOBER 10, 2022); THAT ALL REMONSTRANCE'S WERE HEARD, AFTER WHICH THE GASSVILLE PLANNING AND ZONING COMMISSION RECOMMENDED THAT ALL PROPERTY HEREIN BE REZONED.

THE FOLLOWING REAL ESTATE LOCATED IN THE CITY OF GASSVILLE, ARKANSAS (BAXTER COUNTY) SOUTH OF CC DRIVE AND ARROWHEAD DRIVE CONTAINING 9.05 ACRES M/L OWNED BY ARLYND MALLETT, BE AND IS HEREBY CHANGED IN ZONING FROM RESIDENTIAL (R-3) TO COMMERCIAL (C-2).
